COVID-19 EFFECT ON COMMERCIAL VEHICLE MARKET

- ACT Class 8 and Class 4-7 2020 truck sales forecasts reduced significantly over pre-pandemic estimates
- Truck manufacturers' temporary production stoppages negatively impacted Q2 activity
- Customers delaying truck purchases
- Parts supply chain largely uninterrupted
- Experienced significant negative impacts on truck sales and aftermarket revenues in Q2
- Investments we made in strategic initiatives may mitigate impact on aftermarket products and services business




LIQUIDITY AND EXPENSE REDUCTION







ABSORPTION PERFORMANCE


